This may please be noted that as already notified by the University on September 21, 2024, the candidates who have already appeared at the Entrance Test conducted on September 13, 2024 will be called first by the Admission Board. After exhaustion of this list, the candidates who have qualified the entrance test on September 24, 2024 will be called by the Admission Board for provisional admission.

#### Reservation of seats:

Reservation of seats for admission will be made as per the reservation policy of the State Government. Candidates belonging to other states shall be considered in general category.

### **Important:**

- 1. It may please be noted that as per Gazette Notification dated February 16, 2023 of Medical and Health Department, Government of Rajasthan Regulation 42 of the Rajasthan Para-medical Council (Amendment) Regulation, 2023, "person who has domicile of Rajasthan shall be eligible for registration in Rajasthan".
- 2. Before coming to attend the counseling, candidates are advised to self-check and ensure their eligibility for the admission. Candidates who do not fulfill the eligibility shall not be allowed to appear before the Admission Board for the counseling.
- 3. Candidates whose results of Senior Secondary (10+2) examination are still awaited, shall also not be allowed to appear before the Admission Board.
- 4. Following relevant Original documents and one set of self-attested photocopy of the documents are to be brought by the candidate at the time of Counseling otherwise the candidate shall not be allowed for the Counseling:
  - Marks sheet of 10+2 (Senior Secondary) Examination.
  - Marks sheet/Certificate of the Secondary Examination (10<sup>th</sup> Class) showing date of birth.
  - Transfer Certificate from the Institute last attended.



- Character Certificate from the Head of the Institute last attended.
- Valid Certificate for Reservation Category (EWS/SC/ST/OBC-NCL/MBC- NCL etc.) if category is other than General Category.
- Domicile Certificate.
- Aadhar Card.
- Disability Certificate, if applicable.
- No objection certification/permission from the present employer for the applied regular full-time program (for in service candidate only).
- Migration Certificate from the concerned Board/University (in case the University is other than the MGUMST).
- Other relevant certificate(s), if any.

The candidate selected for provisional admission shall be required to deposit Rs. 1,20,500/- (Tuition Fees Rs. 90,000/-, Enrolment Fees Rs. 13000/-, Eligibility Fees Rs. 7500/- and Caution Money Rs. 10,000/-) up to Monday, September 30, 2024 through:

Proof of deposition of above amount along with two post-dated cheques (one of dated 01.07.2025 and another of 01.07.2026) each of Rs. 90,000/- in favour of Mahatma Gandhi University of Medical Sciences and Technology, Jaipur for the remaining two years course duration tuition fees will be required to be submitted in the office of Convener, Admission Cell, MGUMST latest by **Monday, September 30, 2024**.

The Admission Board shall verify all the original documents of the candidates and shall issue provisional admission letters to suitable candidates.



No extension in the last date of deposition of fees/postdated cheque(s) shall be granted in any case.

In case a candidate does not deposit fees and postdated cheque(s) in time, provisional admission granted to the candidate shall stand cancelled and next candidate in waiting list shall be given offer.

Required Undertakings/Declarations/Affidavits etc. by the candidate and/or parent shall be submitted in the office of the Principal, Mahatma Gandhi Institute of Allied Health Sciences before the date Tuesday, October 01, 2024, i.e. the start of the session 2024-25.

#### NOTE:

- 1. In case, it is found that a candidate does not fulfill the conditions of eligibility prescribed as per the Notification/Rules, the University shall cancel his/her admission at any stage.
- 2. Candidates shall have to abide by all rules/regulations of the University.
- 3. In case, a candidate discontinues the course after the admission on any account, the fees and the postdated cheque(s) deposited by him/her shall be forfeited.
- 4. The University reserves the right to make changes in the Guidelines/Rules at any time. The decision of the University shall be binding on all.
- 5. All disputes in relation to the matters pertaining to admission to any of the above courses of the University shall be subject to the jurisdiction of Hon'ble Rajasthan High Court, Jaipur Bench only and not at any other place.
